Entries close – 20th May 2025, no refunds after this date.

Area Qualifier (Senior, Junior & Mini)

Class 1: SENIOR SECTION

Teams to comprise of three members aged under 25 years on the 1st January of the competition year. One member to be 16 years or under on 1st January of the competition year. Of the remaining two Members, one may be between 21 and 24 on 1st January of the competition year. Questions will be based on the Care section of the C+, B and AH Efficiency Test cards.

Class 2: JUNIOR SECTION

Teams to comprise of three members. Ages to be 14 years and under on the 1st January of the competition year, with one member to be 11 years or under on 1st January of the competition year. Questions will be based on the Care section of the D, D+, C and C+ Tests and Horsemanship achievement badges. At the Championships a small number of questions will cover Advanced Achievement Badges.

Class 3: MINI SECTION

Teams to consist of three members. Ages to be 10 years and under on the 1st January of the competition year, with one member to be 8 years or under on the 1st January of the competition year. Questions will be based on the Care section of the E and D and easier parts of the D+ Efficiency Test cards and Mini Horsemanship achievement badges.

Prizes – 1st to 8th rosettes for teams in all classes

Catering: There is an on-site cafe with indoor and outdoor seating overlooking the arenas at Wellington Riding serving a selection of hot and cold food and drink.

Timings:

We will aim to begin the day with arrival at 9:30 for 10:00 start. However, THIS MAY CHANGE and the full timings will depend on the number of teams entered. Classes may run in any order depending on entries. An email will be sent out to Team Managers with timings for each class on or before 23rd May 2024. CONDITIONS OF ENTRY

- To be run under Pony Club Rules 2025.
- This Competition is open to Teams of 3 from Pony Club Branches and Centres in Area 13.
- Competitors should dress in an appropriate manner suitable for safe working in the stable environment i.e. Centre/Branch sweatshirt with jodhpurs and boots.
- All competitors must wear PC tagged riding hats when handling horses, and gloves where appropriate.
- The judges' decision is final.
- PROTESTS OR OBJECTIONS: Apart from the Official Steward, the Area Representative and Officials of the competition, only District Commissioners/Centre Proprietors or their appointed representatives are entitled to lodge protests or objections. Protests must be made in writing and addressed to the Organiser. They must be accompanied by a deposit of £25, which is forfeit unless it is decided that there were good and reasonable grounds for the objection.
- Please note this is a no smoking site throughout.
- Entries close on 20th May 2025.
- Ages as of 1/1/2025.

IMPORTANT: Each team MUST provide at least ONE helper for their part of the competition.
