**Classes 1,2, 3,5 and 7 to be a maximum of 10 fences:**

**Classes 4, 6 and 8 will be full XC courses.**

**\*Assistance on the course:** Classes marked with an \* may have assistance given on the course by a suitable adult if required.

**Entries:** to be made via My Riding Life by Wednesday 13<sup>th</sup> November 2024

- Members : Clear Round entry is free! : Competition Round is £5 per class.
- Non Members (Juniors only): Clear Round £3 per class : Competition £5 per class. Plus £5 non membership charge for the day.

**Horses/ponies:** May compete in a maximum of two classes.

**Tack:** Usual tack rules apply; martingales or leather neck straps are compulsory.

**Dress Code:**

- Pale jodhpurs, XC colours or Pony Club jumpers/rugby tops.
- Skull caps (Pony Club tagged), body protectors and neck straps/martingales are compulsory.
- **No jewellery** is allowed (other than medical jewellery and a wristwatch)
- If the rider has a medical condition that may impact on their care in case of an emergency, a medical armband must be worn.
- Please see specific hat and body protector rules below

**Times:** Approximate times for each class will be emailed out on Wednesday 20<sup>th</sup> November







**Course Walk:** The XC course will be ready to walk from 2pm on Saturday 23<sup>rd</sup> November. There will not be time to walk the course between classes.

**Competition classes:** will be judged on optimum time with faults as follows:

First refusal, run-out or circle of horse at obstacle	20 penalties
Second refusal, run-out or circle at same obstacle	40 penalties
Third refusal, run-out or circle at same obstacle	Elimination
Forth refusal around the course	Elimination
Jumping a smaller alternative	15 penalties
Fall of rider	Elimination
Fall of horse	Elimination

## Body Protector Rule

BETA 2018 Level 3 standard (blue and black label) body protectors are compulsory and must also be worn at all times whilst mounted.
