Booking Terms and Conditions.

Legal Liability: Save for the death or personal injury caused by the negligence of the organisers, or anyone for whom they are in law responsible, neither the organisers of this event or The Pony Club nor any agent, employee or representative of these bodies, nor the landlord or his tenant, accepts any liability for any accident, loss, damage, injury or illness to horses, owners, riders, spectators, land, cars, their contents and accessories, or any other person or property whatsoever. Entries are only accepted on this basis.

Health & Safety: Organisers of this event have taken reasonable precautions to ensure the health and safety of everyone present. For these measures to be effective, everyone must take all reasonable precautions to avoid and prevent accidents occurring and must obey the instructions of the organisers and all the officials and stewards.

Riders who are not members of The Pony Club are not covered by The Pony Club insurance and must have their own third party cover. The Puckeridge Hunt Western Branch of The Pony Club and the organisers of this event are not legally responsible for non-Members and their insurance will not cover you.

The Pony Club Handbook 2024

Luffenhall rules of use:

- All riders must be accompanied by another responsible person (who may be mounted or un-mounted) who must have access to a mobile phone in order to summon assistance in the event of an emergency.
- Under 18s must be accompanied by an adult.
- Hats and body protectors must conform to The Pony Club rules (see guides).
- It is compulsory to give way to members of the public using the public footpaths that cross the course.
- Visiting dogs are permitted but must be kept on leads and under control at all times.

- All gates must be kept closed at all times and it is compulsory that you read and obey signs and notices around the site.
- Riders must not jump any jump marked with 'crossed flags' as this indicates that the jump must not be used under any circumstances.
- Riders / coaches must inspect the woodland pathway at the top of the course for any hazards (such as rabbit holes, over-hanging brambles and the like), prior to sending through any horses.
- Riders and their trainers, spectators, helpers must not take any glass or breakable objects onto the facilities. Smoking, alcohol consumption and the use of BBQs on the course is strictly prohibited. We ask that all your belongings and any rubbish is taken away with you, this includes any hay or droppings in the parking area.
- All visiting horses must have a valid passport and be vaccinated within the last 12 months. Any horses showing signs of illness should not be brought on site at any time.
- Any damage to fences should be reported to the organisers. In the event of damage, reasonable costs may be charged for repair or replacement.
