## Substitutions

Area Competitions – after the closing date for declarations, no substitutions may be made of horses or riders except in cases of illness, lameness or other unavoidable circumstances which must be certified in writing by the District Commissioner or his appointed representative. In such a case:

- i. If a horse has to be substituted an alternative rider may be nominated.
- ii. If a rider has to be substituted an alternative horse may be nominated.
- iii. If a Branch enters two teams under Rule 5, substitution may be made from one team to the other.

## Withdrawals & Refunds

Full refunds will be given up until the closing date of the competition.

After the closing date no refunds will be made without a doctors' or Vets certificate produced no later than 24 hours after the event. If produced after this no refunds will be given.

Refunds where due after the closing date are subject to an admin fee of: £5

In the event of abandonment 50% of the entry fee will be refunded.

## ENTRY CONDITIONS:

To be run in accordance with Pony Club Dressage Rules 2024

Please ensure your members comply with 2024 eligibility, hat tagging, body protector and medical armband rules and responsible adult present.

Late entries may be accepted at the organiser's discretion. **Late Entry Surcharge £ 10**

Queries may only be raised via the Secretary by the DC or their appointee. Protests / objections will be managed as per Rule 5.

Combination of Horse and Rider CAN compete at two adjacent levels of the same Sport at the Area Competition or at the Championships. Apart from at BOTH GRASSROOTS & NOVICE. See Eligibility Rule 4 / 2.

Photographic Rights – competitors and their parents/guardians have given permission for any photographic and/or film or TV footage taken of persons or horses/ponies taking part in Pony Club events to be used and published in any media whatsoever for editorial purposes, press information or advertising by or on behalf of the Pony Club and/or Official Sponsors of the Pony Club.

A valid passport and vaccination record must accompany the horse/pony to this event and must be available for inspection if required by event officials. Vaccinations must be in accordance with the Pony Club Dressage Rule Book 2024.

#### **INSURANCE:**

- The Pony Club 'Public and Products Liability Insurance' Policy includes cover for all the official Area Competitions and the Championships. Details of this insurance are available on The Pony Club website.
- In the event of any accident, loss or damage occurring to a third party or to the property of a third party (including the public and competitors) no liability should be admitted, and full details should be sent at once to The Pony Club Office.
- The following statements should be included in all event schedules:

#### **LEGAL LIABILITY:**

- Save for the death or personal injury caused by the negligence of the organisers, or anyone for whom they are in law responsible, neither the organisers of this event or The Pony Club nor any agent, employee or representative of these bodies, nor the landlord or his tenant, accepts any liability for any accident, loss, damage, injury or illness to horses, owners, riders, spectators, land, cars, their contents and accessories, or any other person or property whatsoever. Entries are only accepted on this basis.

#### **HEALTH, SAFETY & WELFARE:**

- Organisers of this event have taken reasonable precautions to ensure the health and safety of everyone present. For these measures to be effective, everyone must take all reasonable precautions to avoid and prevent accidents occurring and must obey the instructions of the organisers and all the officials and stewards.

#### **REASONABLE ADJUSTMENT:**

- Application is via the member's Personal Profile. This Form must be submitted, accompanied by the relevant documents from a healthcare professional, to the relevant person (Test Organiser, Competition Secretary, Rally Organiser) at least two weeks before the activity is due to take place. If it is submitted after this date, there are no guarantees that the adjustment will be applied. This timeframe ensures that there is sufficient time for consideration of the application and that any adjustment that is agreed upon is fair and in place. A member's Personal Profile is the way that information about a member's needs are collected. These should be reviewed on a yearly basis or in the event of a significant change to the member's condition. If the Reasonable Adjustment involves a change to the running of a competition (for example, specialist tack or a caller), an application must be made to the relevant Sport Chairman for review. The Adjustment will be considered and, if approved, will be relevant to a specific level of competition. If the member wishes to change competition level, an application to amend the Reasonable Adjustment must be submitted.
