- The course will be ready to walk from 5.30pm on Friday.
- L fences (if used) are smaller, easier alternative fences but incur 15 penalties.
- In the event the fixture must be cancelled, announcements will be made on the NCHPC Facebook Page, the NCPC Facebook page and Pony Club Results.
